- Paris 2024 Olympic Qualification Update Canada will have either one, two or three beach teams in the Paris 2024 Olympic Games (July 26 August 11).
 - Brandie Wilkerson/Melissa Humana-Paredes are assured of qualification into the Paris 2024 Olympic Games via the FIVB Olympic Ranking (Top 18 teams with a limit of 2 teams per country).



- Sarah Pavan/Molly McBain have a possibility to qualify for Paris 2024 through the Olympic Ranking (They are currently 18th ranked team) which will be finalized on June 10, 2024.
- o If Sarah Pavan/Molly McBain don't qualify for Paris 2024 through the Olympic Ranking then Sophie Bukovec/Heather Bansley will compete in the NORCECA Paris 2024 Olympic Qualification Tournament in Tlaxcala, MEX June 21-23, 2024. If Sophie Bukovec/Heather Bansley win this NORCECA event in Tlaxcala then they will qualify for the Paris 2024 Olympic Games.
 - Sam Schachter/Dan Dearing will also be competing in the NORCECA Paris 2024 Olympic Qualification Tournament in Tlaxcala, MEX Jun 21-23, 2024 with a chance to qualify for the Paris 2024 Olympic Games.

- WPV Final Qualifier in Dali, CHN in April 1-10, 2024
- Men finished 4th. Strong showing. Ukraine finished 1st and received Paralympic berth.
- Debrief process and program review underway. Upcoming plans depend on 24-25 WPV calendar of events which has not been released.
- The men's program will face some financial limitations for remainder of the year, due to the high cost of Final Qualifier. Will need to be strategic in scheduling training camps and selecting appropriate competitions when available.

International Events

VNL 2024 (Jun 4-9, Ottawa)

- Planning going well, all on track
- Ticket sales a bit ahead of last year at same time
- School day program will have over 3500 kids attending; coaching symposium at 60 already

U21 Women's NORCECAs (Jun 25-30 Toronto)

- Teams and match schedule have been confirmed; no Cuba
- CC being confirmed and flights booked.

NORCECA Men's Final 6 (Aug 20-25 Gatineau)

Competition format has been confirmed.

Beach Pro Tour (Aug 29- Sep 1, Montreal)

- Event is looking somewhat tenuous now; govt funding.
- Previous promoter is out; new promoter being sought
- Considering the option of moving the event to Quebec City

VNL 2025-2027

- Have indicated that VC is prepared to host VNL 2025-2027, for 2 events (each gender) per year
- Ottawa has confirmed, currently soliciting second host city

IST

Men's Update:

- Currently 2.5 weeks into training camp. Completed our full athlete intake process with U21
 and Senior athletes with Next Gen coming up May 13-14. Athletes are given a thorough
 diagnostic of sport medicine testing, performance-based testing, biomechanical based
 testing, and attend workshops for specific nutrition/mental performance and mental health.
- Brendan Dinsdale, who has been a mental performance consultant with our NEP and U21 programs for 2.5 years is also now our Mental Health Liaison for athletes, coaches, and staff. In this new role he oversees working on our mental health emergency action plan, conducting regular check-ins with athletes, staff, and coaches, and is the direct link to the various resources for mental health in sport.
- Mikael Kannaan, who is a PhD student at University of Ottawa, will be a part time, assistant strength, and conditioning coach with our Next Gen squad for this summer. This is the first time the program has had a 3rd S&C coach.



WNT:

- · Currently in Round one of VNL Rio
- We've continued to implement our new nutritional strategies around supplements and meal timings while travelling
- We're collecting our first in game data with our new catapult system for analysis to determine the detailed physical demands of our sport
- Continuing the onboarding and upskilling process with our new AMS

Safe Sport/Gender Equity, Diversity & Inclusion

- As of May 20, 2024, VC has five (5) individuals on the Abuse-Free Sport Registry with Sanctions and another eight (8) with Provisional Measures applied pending the completion of their cases.
- Abuse-Free Sport will be housed under CCES (instead of SDRCC) as of April 1, 2025. Both organizations are using the time between now and then to prepare for the full transfer.
- All members will now be required to sign the UCCMS consent form directly through Abuse-Free Sport rather than through signing a waiver through VC/PTA. VC will adopt this requirement at the National level by June 30th but has requested a transition for this requirement for the PTA membership in the new registration season. This has been approved by SDRCC and we are working with PTAs on the implementation plan. Board members can expect to receive the email to sign the member consent form through Abuse Free Sport in the next week for so. This process includes the required training video and takes approximately 10-15 minutes.
- The Safe Sport for Youth Education Videos will be ready for launch in English and French in early June.
- VC received Sport Canada funding for gender equity initiatives in Refereeing and High-Performance Coaching with initiatives being implemented at National Championships and Canada Cup.

Communications

- Planning meetings for international events (VNL and NORCECA) well underway in comms/marketing.
- Nationals Comms play currently being executed, 14U completed, festival event in Edmonton underway. Streams on YouTube/CBC.
- Continue to develop and add freelance content providers (video, photographers, other content creators) to help get through major events.
- Planning for HoF content (videos) in final stages.
- Ongoing: Working with sport partners COC and CPC on upcoming team announcements for Paris; and coverage of major National Team activities. Jackie to attend Olympics (COC mission staff); Courtney to attend Paralympics (CPC mission staff).
