• Referee Development Manager

- Started working with the PTA Referee groups in preparation for the 2020 National Championships in Edmonton
- PTA Safesport survey via the Referee Executive is complete and data is being tabulated. Preliminary results suggest that we need to do more on the referee end of the equation
- Working with various colleagues in the United States to streamline the administrative requirements for referees traveling south to participate in various competitions
- Interests for the beach sub-committee have been received and Bob Rocque is currently reviewing names to finalize the sub-committee

- This event completed successfully however the biggest issue was the last minute withdrawal of Suriname, forcing us to re-plan the event at the last minute;
- Final results: CUB, USA, CAN, Mexico. Thus the Olympic Qualifier in January will include CUB, CAN, MEX, PUR.
