- The 2023 VC Beach Induction Camp took place January 4-6, 2023. Full-time Next Gen Training began on Monday January 9, 2023.
- Own The Podium (OTP) Beach Funding for 2023-24 (April 1, 2023 to March 31, 2024) will be communicated to VC on January 16, 2023.



- Upcoming FIVB (Volleyball World Beach Pro Tour) events:
 - Sarah Pavan/Sophie Bukovec will compete in the Beach Tour Finals in Doha. Qatar January 25-29, 2023.
 - Sarah Pavan/Sophie Bukovec and Melissa Humana-Paredes/Brandie Wilkerson are competing in the Doha Elite 16 event (February 1-5, 2023). This is the first event in the Paris 2024 Olympic Qualification System.
- VC NORCECA Closed Trials will take place February 23-24, 2023 at the VC Beach High Performance Centre in Downsview Park. This event will determine the teams that represent Volleyball Canada at 2023 NORCECA Beach Tour events that occur in the first half of 2023.

Sitting Update

- Nicole, Ian and Mark E attended OTP Review on Nov 23 which went well
 - Funding recommendation expected Jan 13
 - Funding ask for 2023-24 was \$490,205 (increase from \$350,000 in 21-22)
 - increases included FT HPD, training/exhibition w BRA in April 23
- MW National Teams are beginning preparations for Zonal Championship in May 2023 (Edmonton)
 - Women
 - Jan training camp, Feb training camp, March exhibition with USA, April exhibition with BRA
 - Men
 - o Feb training camp, Mar training camp, April exhibition TBD

2023 ParaVolley Pan America Zonal Championship (Edmonton, May 2023)

- \$250k received from Sport Canada
- PVPA expects participation from 8 men's countries and 6 women's countries, which would be largest Pan Am Zonal Championship ever held

Referee

- Delivered training to the Referee Committee and Provincial Referee Leadership regarding UCCMS, OSIC and Safe Sport policies and procedures
- Providing Gender Equity training to the Referee Committee and all Provincial Referee Leadership
- Collaborating with the Women's National Team and NEP programs to develop year-round training opportunities for high performance referees
- Engaging current IST leads to look at potential opportunities to expand into referee programming on both the high performance and grass roots levels

National Competitions

- Registration successful overall. One minor glitch with 15UB. 15UB numbers higher than anticipated. Regina is tight on hotels, currently a 50ish teams on the waitlist; 96 teams in.
- 16U registration went very well with invites tomorrow will be at 80 boys teams and 160 girls teams
- Jerry Dee Reached out to work with Nationals to identify top 24 16U 18U female athletes.
 Wants to offer an all expenses paid trip for a showcase match in Toronto in Early June.
- Looking to work with various VC departments to visit the Territories in fall 2023 for a Combine along with other opportunities (referees, coaches, athlete development)

- Beach Pro Tour
 - Have been assisting Ed with beach tour events in Montreal and Edmonton
 - Montreal seems a go; Edmonton not so sure
- Paravolley Qualifier
 - Contracts signed for Paravolley Qualifier event; to start inviting teams
 - Edmonton in May 10-14 in association with Nationals
 - Sport Canada hosting grant approved for \$250,000

VRL/LMS

- Nationals registration started Jan 11
 - o One small issue encountered
 - o Trying to keep up PIA certifications
- LMS RFP to go out next week

IST

All programs:

- Resigned a new 4yr agreement with Kinduct as our Athlete Management System provider for both men and women's indoor, and men and women's sitting.
- Officially, we were notified that PUSH (our S&C software and accelerometers) will be discontinued. PUSH was bought out by WHOOP, and they will be going in a different direction as a company. We recently purchased Team Buildr for our S&C programming software, and this has been adopted by all programs within Volleyball Canada. We are currently looking into accelerometer replacements.
- We will be having our first Volleyball Canada IST "water cooler" meeting this month between all programs. The intent is to share and collaborate resources and ideas across our programs.

MNT:

- We will be posting, by the end of January, a contracted position for a Mental Performance Consultant with our Senior Team
- We will be posting our professional development opportunity for a University Strength and Conditioning Coach to spend time with our programs May-June and be involved in the VNL prep and the Ottawa VNL week. This is part of our goal to continue building relationships with universities along with developing capacity within our programs on the pathway.

WNT:

 Currently looking for a new Medical Coordinator and lead Physiotherapist. The position is currently being advertised until Jan. 20th. Anticipated start date is March 1.

Safe Sport/Gender Equity, Diversity & Inclusion

- An update on the number of Safe Sport Cases being reviewed by Abuse-Free Sport will be
 provided in mid-January. We are aware that several new cases have been added since the last
 update and all at the PTA or Club levels. Several members have had interim membership
 suspensions and/or other interim measures imposed as part of the Abuse-Free Sport Complaint
 process.
- The OVA has been selected by OSIC for an Environment Assessment based on a complaint that they received. OVA and VC will learn more about the process in an upcoming meeting with OSIC. The information posted on OSIC's website states:
 - Assessment accepted Scoping phase ongoing- Impacted sport environment:
 Ontario Volleyball Association Alleged systemic issues: forms of discrimination and other prohibited behaviour under the UCCMS.



- Caroline Sharp staged a workshop with the BC Volleyball Board in early January on the Abuse Free Sport Program and Complaint process. Julie Young staged a similar session with Referee leadership and PTA ROC's.
- A Safe Sport Complaint process review session was staged in early January as part of the Beach HP Camp and sessions will be staged with each National Team Program for the new season.
- The Youth Safe Sport training tool is progressing well, with Vantage Point initiating a survey to clubs regarding the tool. Meetings were staged with various clubs across the three sports of Volleyball, Athletics and Swimming to obtain input and feedback on the youth training tool. The next phase involves athlete/parent input. Vantage Point Consulting is working on finalizing an agreement with ITP to develop the content for the tool, including the production development. Work is on-going to seek funding from the COC for the next phase of the project and they have recently confirmed \$85,000 in additional funds.
- The DEI framework project with Deloitte is completed following a session staged in December. VC will be working on the next steps and action plan.

Communications

- Staffing update: new communications coordinator starts on Jan. 16. Focus on Nationals comms planning as well as overall comms assistance.
- Marketing and communications planning for international events VNL marketing plan in progress. Campaign to begin in early Feb.
- Continue to work with all programs to support consistency in messaging and branding.
- Continue to work with partnership coordinator to integrate partner/sponsor content on key channels.
- Developing content calendar for 2023 based on information currently available.

Partnerships / Merchandise

- Finalizing the contract with Mizuno, should be signed off in January. Team staff have begun the order process for 2023 season.
- Mikasa custom VC branded beach ball in the works. Targeted towards the recreational/adult league category.
- Left on Friday swimwear outfitted the women's beach team at the induction camp in January.
- Negotiations ongoing for eyewear and men's beach categories.
- Discussions ongoing to target new sponsors to fill additional categories
